The Executive Director presented the Commission regarding the Declaration of Emergency Rule regarding license renewal fees suspensio for Louisiana-based business licensees. This Emergency Rule is enacted pursuant to the authorization and direction of the House Concurrent Resolution No. 71 of the 2020 Regular Session of the Louisiana Legislature, passed on June 1, 2020:

**DECLARATION OF EMERGENCY  
Office of the Governor  
Motor Vehicle Commission**

License Renewal Fees Suspension for Louisiana-Based Business Licensees (LAC 46:V.Chapters 21 and 81)

On January 31, 2020, the United States Department of Health and Human Services Secretary Alex A. Azar declared a public health emergency (PHE) for the United States to aid the nation's healthcare community in responding to the coronavirus disease (COVID-19). The United State Centers for Disease Control and Prevention (CDC) declared COVID-19 a worldwide pandemic due to its global effect. Furthermore, on March 13, 2020, the President of the United States invoked the Stafford Act and declared a national emergency regarding the COVID-19 outbreak. On March 11, 2020 Louisiana Governor John Bel Edwards issued Proclamation No. JBE 2020-25, declaring a Public Health Emergency in the state of Louisiana due to COVID-19. Reference is also made to Proclamation No. JBE 2020-33 (dated March 22, 2020) and Proclamation No. JBE 2020-41 (dated April 2, 2020).

This Emergency Rule is enacted pursuant to the authorization and direction of the House Representatives and the Senate expressed in House Concurrent Resolution No. 71 of the 2020 Regular Session of the Louisiana Legislature, passed on June 1, 2020. This Emergency Rule addresses the impact of the COVID-10 disruption to the normalcy previously enjoyed by citizens of Louisiana and the detrimental impacts upon various licensees of the Louisiana Motor Vehicle Commission.

The disruption caused by COVID-19 to the normalcy previously enjoyed by Louisianans is an immediate threat to the public health, safety, and welfare of the Louisiana citizens and businesses. In order to respond to the emergency and to protect and safeguard the public, health, safety and welfare of the citizens of this state, and to comply with the Legislature's will as expressed in House Concurrent Resolution No. 71 of the 2020 Regular Session of the Louisiana Legislature and its established time limitations, it is necessary to issue this Emergency Rule.

**Subpart 3. Motor Vehicle Sales Finance**

**Chapter 81. Suspension of the Renewal Fee for Louisiana based businesses to finance motor vehicles pursuant to R.S. 6:969.1 et seq. and Administrators**

**§8101. Purpose**

A. This Emergency Rule provides for the suspension of license renewal fees for businesses based in Louisiana to finance motor vehicles pursuant to R.S. 6:969.1 et seq. and Administrators who have been negatively impacted by the related commercial and economic impacts of COVID-19, in accordance with Proclamation No. JBE 2020-33, issued on March 22, 2020, by Governor John Bel Edwards declaring a stay at home order and closure of nonessential businesses until April 13, 2020 and Proclamation No. JBE 2020-41 issued on April 2, 2020, declaring a stay at home order and closure of nonessential businesses until April 30, 2020 and House Concurrent Resolution 71 of the 2020 Regular Session of the Louisiana Legislature, enrolled June 1, 2020.

**§8103. Applicability and Scope**

A. License renewal fees are applicable to extenders of credit to finance motor vehicles and for Administrators pursuant to R.S. 6:969.1 et seq. whose business is based in Louisiana with an expiration date falling in the time period from July 1, 2020 through June 30, 2021, are suspended until July 1, 2021.

**§8105. Definitions**

A. For the purposes of this Emergency Rule, suspension of renewal fees for licensees of the Louisiana Motor Vehicle Commission whose business is based in Louisiana, the following terms are defined as follows.

*Administrator*—as defined in R.S. 6:969.6(1).

*Extender of Credit*—as defined in R.S. 6:969.6(17)

**§8107. Suspension of Time to Renew and Licenses to Remain Valid**

A. The time for renewal of licenses for extenders of credit to finance motor vehicles and for Administrators pursuant to R.S. 6:969.1 et seq. whose business is based in Louisiana and having an expiration date falling in the time period from July 1, 2020 through June 30, 2021 is suspended until July 1, 2021.

B. During the suspended renewal period pursuant to this Emergency Rule, the current license of an extender of credit whose business is based in Louisiana to finance motor vehicles pursuant to R.S. 6:969.1 et seq. and the current license of Administrators whose business is based in Louisiana shall remain valid unless surrendered, suspended or revoked.

**§8109. Effective Date**

A. This Emergency Rule, suspension of license renewal fees for Louisiana Motor Vehicle Commission licensees whose business is based in Louisiana, shall become effective at 12:01 a.m. on June 15, 2020 and shall continue in full force and effect until expiration on June 30, 2021, 11:59p.m.

**§8111. Severability**

A. If any section or provision of this Emergency Rule, suspension of license renewal fees for licensees of the Louisiana Motor Vehicle Commission whose business is based in Louisiana or its application to any person or circumstance is held invalid, such invalidity or determination shall not affect other sections or provisions or the application of this Emergency Rule, suspension of license renewal fees for licensees of the Louisiana Motor Vehicle Commission whose business is based in Louisiana, to any persons or circumstances that can be given effect without the invalid section or provision or application, and for these purposes the sections and provisions of this Emergency Rule, suspension of license renewal fees for licensees of the Louisiana Motor Vehicle Commission whose business is based in Louisiana, and the application to any persons or circumstances are severable.

The Executive Director advised the Commission Members a pre-hearing had been held on March 9, 2020, pursuant to LSA-R.S. 49:961C, regarding Hearing #2020-008, Dealmakers, L.L.C., 1720 Old Spanish Trail, Slidell, Louisiana 70458, for alleged violations of LSA-R.S. 6:969.35.A.(1) Authority to make consumer loans; assignees; authority to issue debt waiver or debt forgiveness agreements and Louisiana Administrative Code Title 46. Part V. Subpart 3. Chapter 73. Licensing §7301.A.(1)(a) & (b) License Requirement and Exception In attendance representing Dealmakers, L.L.C. was Ray Vicedomini, salesperson; and representing the Commission were: Chairman Allen Krake; Counselor Gregory F. Commissioner Redmond made a motion to accept and ratify the Consent Judgment in this matter. Commissioner Marcotte seconded this motion and it was unanimously approved.

**CONSENT JUDGMENT**

After considering the entire record in this matter and the interest of the parties in amicably resolving it, the parties have consented to a judgment in favor of the Louisiana Motor Vehicle Commission based upon alleged violations by Dealmakers, L.L.C. of LSA-R.S. 6:969.35.A.(1) Authority to make consumer loans; assignees; authority to issue debt waiver or debt forgiveness agreements and Louisiana Administrative Code Title 46. Part V. Subpart 3. Chapter 73. Licensing §7301.A.(1)(a) & (b) License Requirement and Exception. Therefore, based on the parties' mutual consent;

**IT IS HEREBY AGREED** by and between Dealmakers, L.L.C. and the Louisiana Motor Vehicle Commission that respondent waives:

- A. Any further procedural rights or remedies afforded under the law;
- B. The requirement that the Commission's judgment recites statement of a findings of fact and conclusions of law; and
- C. All rights to seek judicial review or otherwise to challenge or contest the validity of the judgment entered pursuant to this agreement.

**IT IS HEREBY FURTHER AGREED** the Notice of Hearing may be used in construing the terms of the order. No agreement, understanding, representation or interpretation not contained in the order or the agreement may be used to vary or contradict the terms of the order.

**IT IS ORDERED, ADJUDGED, AND DECREED** that Dealmakers, L.L.C. in complete satisfaction of all above-referenced violations, pay a fine to the Louisiana Motor Vehicle Commission in the amount of ONE THOUSAND (\$1,000.00) DOLLARS.

**IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that ONE THOUSAND (\$1,000.00) DOLLARS of this fine be suspended conditioned upon Dealmakers, L.L.C. being placed on ONE (1) YEAR probation beginning the date this Consent Judgment is rendered and signed and adhering to all Rules and Regulations of this Commission and Louisiana laws applicable to this Commission during the

probationary period. In the event of a violation during the probationary period, the suspended portion of the fine shall become due and payable in full. The type of violation referenced herein does not include any dealer related disputes.

**IT IS FURTHER AGREED, ADJUDGED, AND DECREED** that Dealmakers, L.L.C. pay the cost of the pre-hearing conference to the Louisiana Motor Vehicle Commission in the amount of FOUR HUNDRED (\$400.00) DOLLARS.

The Executive Director advised the Commission Members a question had been raised regarding the company name of an applicant, "Top 10 Motorsports". After a lengthy discussion, Commissioner Marcotte made a motion "Top 10 Motorsports" was not in violation of the advertising rules. Commissioner Lane seconded the motion. The motion passed with a majority vote. Commissioner Westbrook voted nay.

The Executive Director continued by stating there have been several sales finance applicants with the word "broker" in their name. The Executive Director stated LA- R.S. 32:1252 (5) defines "Broker":

"Broker" means a person who, for a fee or commission, arranges or offers to arrange a transaction involving the sale, for purposes other than resale, of a new motor vehicle or recreational product, and who is not:

(a) A motor vehicle dealer or recreational products dealer, or bona fide employee of a motor vehicle dealer, when acting on behalf of a motor vehicle or recreational products dealer.

(b) A manufacturer, distributor, convertor, or bona fide employee of a manufacturer, distributor, or convertor, when acting on behalf of a manufacturer, distributor, or convertor.

(c) At any point in the transaction, the bona fide owner of the motor vehicle or recreational product involved in the transaction.

The Executive Director added Brokers are required to be licensed by the Commission pursuant to LA-R.S. 32:1254:

A. The following persons shall be licensed by the commission in order to engage in business in the state of Louisiana, regardless of whether or not said person maintains or has a place or places of business in this state, and it is a violation of this Chapter to operate without first obtaining a license:

(8) Brokers

The Executive Director continued by stating LSA-R.S. 32:1261 A. (5) sets forth the following:

A. It shall be a violation of this Chapter:

(5) For a broker:

(a) To hold himself out to any person as a "broker", "purchasing company", "sales agent", or similar title, engaged in the business of broker, or otherwise engaged in the solicitation or procurement of prospective purchasers for vehicles not titled in the name of and registered to the broker, unless the broker holds a valid broker license and is in compliance with the terms of this Chapter.

After a brief discussion, the Commission determined it would be necessary for the applicants as a lender to finance motor vehicles pursuant to LSA-R.S. 6:969.1 *et seq.* whose names holds them out as a "broker" to obtain a broker license pursuant to LSA-R.S. 32:1251 *et seq.* or change their name to avoid further violation of the law.

The Executive Director was directed to include in these minutes the following excerpt from the Louisiana Motor Vehicle Commission meeting immediately preceding this meeting.

"Chairman Krake asked for a review of the March, April, May, June and July financial statements of the Louisiana Motor Vehicle Commission, Motor Vehicle Sales Finance Division, copies of which were before each Commission Member. Commissioner Marcotte made a motion to accept the March, April, May, June, and July financial statements as presented and incorporate into these minutes. This motion was seconded by Commissioner Maurice Guidry and it was unanimously approved."
