In the matter of Wholesale Auto Group, Inc., Counselor LaPeyronnie reported to the Commission Members that Wholesale Auto Group, Inc. filed a Petition for Temporary Restraining Order and Stay, Preliminary and Permanent Injunction, Declaratory Judgment and Writ of Mandamus with the twenty-fourth Judicial District Court. The Commission was ordered to show cause on January 25, 2016. Counselor LaPeyronnie reported further that the court ruled and ordered the all plaintiff's motions and writ were denied and moot. A judgment was signed by Judge Donald A. Rowan, Jr. on January 25, 2016.

The Executive Director advised the Commission Members that there has been an advertising issue regarding sales finance licensees who have "wholesale" as part of their corporate name or DBA. After a discussion, the Commission instructed the Commission staff to notify sales finance companies the basic tenant of advertising legislation and rules is that it must not be false, deceptive, unfair, or misleading and the Commission considers the use of the term "wholesale" indicates a sale other than a retail sale and therefore misleading.

Chairman Brandt called for a reading of the minutes of the January 20, 2016 meeting. Commissioner Duhon made a motion to accept the minutes as read. Commissioner Guidry seconded this motion and it was unanimously approved.




