The Executive Director announced the first order of business would be Hearing #2012-012, Weldbilt Commercial for alleged violations of LSA-R.S. 32:1254A(1) & (4). A court reporter was brought in to record the transcript of this hearing, which will be made a permanent part of the Commission's files.

The Executive Director announced the second order of business would be Hearing #2012-001, Kohler Co. for alleged violations of LSA-R.S. 32:1254A(1); LSA-R.S. 32:1261(1)(h); and Title 46. Part V. Subpart 1. Chapter 5 §513A. A court reporter was brought in to record the transcript of this hearing, which will be made a permanent part of the Commission's files.

The Executive Director advised the Commission Members a bond waiver request had been received on May 1, 2012 from Wayne T. Crochet, Attorney for Petersen Industries, Inc., along with copies of its balance sheet and income statement:

"Along with Richard Anderson, I represent Petersen Industries, Inc., a Florida Corporation who submits the enclosed application to be licensed as a Converter or Secondary Manufacturer.

Pursuant to the application, we are requesting that the statutory bond requirement be waived. In support of that position we submit the following:

- Petersen is an established company in the industry for 50 years with sound finances.
- Petersen has over 900 municipal customers nationwide.
- Petersen has a strong history of warranty support and will have a distributor in Louisiana to service and warrant its product.
- Sales cycles with municipalities can range from weeks to years depending on budget constraints and added costs from bonding would be incorporated into the price to Petersen customers, usually municipalities.
- Petersen's customers are sophisticated buyers who usually, if not always, pursue purchases by bid with specifications.

Please let me know if any additional information is needed in furtherance of the application. I understand that this matter will be placed on the commission's agenda for May 14, 2012 at 9:00 AM."

A brief discussion ensued after the Commission Members reviewed Petersen Industries' balance sheet and income statement. Commissioner Hargroder made a motion to waive the bond requirement of LSA-R.S. 32:1254D(6)(a) for Petersen Industries, Inc. for one license year. Commissioner Ryan seconded this motion and it was unanimously approved.

The Executive Director presented to the Commission Members an e-mail correspondence received on April 25, 2012 from Robert Bell, Senior Account Director of UniWorld Group Inc.:

"Thank you so much for returning my phone call and outlining the process for securing LMVC approval for Ford. In preparation of your May 14 board meeting, following are the details for our static vehicle display and a Ride & Drive program:

Sponsorship: Ford Motor Company has been designated as the exclusive automotive sponsor of the 2012 Essence Music Festival with rights to conduct vehicle displays and a consumer Ride & Drive program:

Load In: Tuesday, July 3

Load Out: Monday, July 9

Also, attached are 3 proposed Ride & Drive routes under consideration:

Super Dome Display: (1) 2013 Ford Escape to be used as a stage prop on July 7.

Vendors: Both the Booth Display and Ride & Drive will be managed by a 3rd Party Event Management Company hired by UniWorld Group (an agent of Ford Motor Company.) It is not our intention to have Ford Dealers onsite to execute our activities.

Please let me know if you require any additional information and advise of next steps with respect to May 14 Agenda."

After a brief discussion, Commissioner Guidry made a motion to approve UniWorld Group Inc.'s request to display and Ride & Drive only, no sales activity, at the Convention Center and Super Dome for the 2012 Essence Music Festival on July 6, 2012 to July 8, 2012, conditioned upon the Law and the Rules and Regulations promulgated by this Commission being strictly adhered to and all representations made in the request correspondence of April 25, 2012, remaining constant. Commissioner Duhon seconded this motion and it was unanimously approved.

Sponsor or participant- a manufacturer or distributor who pays cash or an in-kind fee to an organizer in return for access to the commercial potential associated with the show or event.

CONSENT JUDGMENT

After considering the entire record in this matter and argument of counsel, and in the interest of the parties reaching an amicable resolution, the parties have consented to a judgment in favor of the Louisiana Motor Vehicle Commission based upon alleged violations by Medart, Inc. and Medart Engine - South of LSA-R.S.32:1254A(4) & (5) Application for license; requirements for licensure; contents; licenses; franchise filings; LSA-R.S.32:1261(1)(h) Unauthorized acts; and Louisiana Administrative Code Title 46. Part V. Subpart 1. Chapter 5 §513A. License Prior to Shipment. Therefore, based on the parties' mutual consent;

IT IS ORDERED, ADJUDGED, AND DECREED that Medart, Inc., 124 Manufacturers Drive, Arnold, Missouri 63010-4727 and Medart Engine - South, 10310 High Point Road, Olive Branch, Mississippi 38654, jointly, severally and in solido, in satisfaction of all above-referenced violations, pay a fine to the Louisiana Motor Vehicle Commission in the amount of FIVE THOUSAND AND NO/100 (\$5,000.00) DOLLARS.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that TWO THOUSAND FIVE HUNDRED AND NO/100 (\$2,500.00) DOLLARS of the fine be suspended conditioned upon Medart, Inc., 124 Manufacturers Drive, Arnold, Missouri 63010-4727 filing its 2011 and 2012 applications for a recreational products distributor, and Medart Engine - South, 10310 High Point Road, Olive Branch, Mississippi 38654, filing its 2011 and 2012 applications for recreational products distributor branch licenses within fifteen (15) business days of March 19, 2012, with both being placed on ONE (1) YEAR probation beginning the date of signing of this Consent Judgment and further adhering to all Rules and Regulations of the Louisiana Motor Vehicle Commission and Louisiana laws applicable to the Louisiana Motor Vehicle Commission during the probationary period. In the event of a violation during the probationary period, the suspended portion of the fine shall become due and payable in full.




