DBA Bengal Trailers was in attendance at the hearing. A court reporter was brought in to record the transcript of the hearing, which will be made a permanent part of the Commission's files. JUDGMENT

This cause came to be heard on Monday, May 8, 2017 before the Louisiana Motor Vehicle Commission (the "Commission"). Tiger Axles, Inc. DBA Bengal Trailers, 6711 West 70th Street, Shreveport, LA 71129, did not appear at the time of the hearing, even though properly noticed via certified mail, receipt returned.

And after hearing the testimony adduced at trial, the receipt of documentary evidence into the record, and for reasons orally assigned, the Commissioners of the Louisiana Motor Vehicle Commission ("the Commission") make the following findings of fact and conclusion of law:

Findings of Fact:

- After July 31, 2016, Tiger Axles, Inc. DBA Bengal Trailers was not licensed by the Commission as a manufacturer of recreational products;
- After July 31, 2016, Tiger Axles, Inc. DBA Bengal Trailers was not licensed by the Commission as a recreational products dealer;
- On September 19, 2016, Tiger Axles, Inc. DBA Bengal Trailers, offered to manufacture trailers, and as such acted in the capacity of a manufacturer of recreational products in Louisiana without being licensed by the Commission;
- On September 19, 2016, Tiger Axles, Inc. DBA Bengal Trailers offered to sell recreational products in Louisiana, and as such acted in the capacity of a recreational products dealer in Louisiana without being licensed by the Commission; and
- Tiger Axles, Inc. DBA Bengal Trailers offered to manufacture and sell two trailers in the State of Louisiana after its license issued by the Commission had expired.

Conclusions of Law:

- By operating as a manufacturer of recreational products without a license, Tiger Axles, Inc. DBA Bengal Trailers violated LSA-R.S. 32:1254.A.(1); and
- By operating as a recreational products dealer without a license, Tiger Axles, Inc. DBA Bengal Trailers violated LSA-R.S. 32:1254.A.(18).

Considering the forgoing and pursuant to the authority vested in the Louisiana Motor Vehicle Commission set forth in LSA-R.S. 32:1251, et seq.:

IT IS ORDERED, ADJUDGED AND DECREED that Tiger Axles, Inc. DBA Bengal Trailers be and is hereby assessed a fine in the amount of TWENTY THOUSAND AND NO/100 (\$20,000.00) DOLLARS.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Tiger Axles, Inc. DBA Bengal Trailers pay the cost of the full board hearing to the Commission in the amount of TWO THOUSAND FOUR HUNDRED AND FIFTY-EIGHT DOLLARS AND FIVE CENTS (\$2,458.05), in addition to the TWENTY THOUSAND DOLLARS (\$20,000.00) fine assessed herein.




