The display and ride and drive will be managed by AMCI, a 3rd party event management company hired by UniWorld Group (an agent of Ford Motor Company).
No Ford dealers will be engaged to have consumer interaction at the conference, nor will dealer material of product brochures be distributed.

Thank you in advance for your assistance and consideration. Please contact me if you have any questions.”

After a brief discussion, Commissioner Lane made a motion to approve Ford Motor Company’s request as presented, conditioned upon the Law and the Rules and Regulations promulgated by this Commission being strictly adhered to and all representations made in the request correspondence of September 7, 2016, remaining constant. Commissioner Hightower seconded this motion and it was unanimously approved.

The Executive Director reported to the Commission Members regarding the effects of August flooding to our licensees in Baton Rouge and Denham Springs area and seeking a direction from the Commission Members on how to handle flooded dealership licensees. A discussion ensued regarding the effects of the August flooding on the licensees of the Commission. The Commission Members decided to remain consistence with the policy regarding the effects of Hurricane Katrina on the licensees in 2005. Commissioner Lala made a motion to adopt the same policy in effect after Hurricane Katrina and Commissioner Fontenot seconded this motion and it was unanimously approved.

Excerpt from September 13, 2005 Minutes:

“A discussion ensued regarding the effects of Hurricane Katrina on the licensees of the Commission. After a lengthy debate and review of the statute the Commission, Commissioner Mann made a motion to adopt the following policy:

1. Dealers will not be allowed to operate, either sales (motor vehicles or parts) or service, outside of their primary area of responsibility. This is based upon information from the manufacturers, historic practices of the Commission, and our statute.
2. Those dealers who wish to operate from a temporary location within their primary area of responsibility shall:
 - a. With manufacturers approval, apply to the Commission for a license to operate for a period of 60 days from that location.
 - b. Submit to the Commission a plan of operation from that temporary site.
 - c. Within 60 days of the issuance of the license for the temporary location submit to the Commission its plan of renovation or construction for its permanent location. Based upon this plan further licensing will be considered for the temporary location.
 - d. Commissioner Braxton seconded this motion and it was unanimously approved.”

In attendance representing Parish Truck Sales, Inc. was Brian Bennett, Owner and Vincent Booth, Attorney for Parish Truck Sales, Inc. JUDGMENT WITH FINDINGS OF FACT AND CONCLUSIONS OF LAW

On September 12, 2016, there was held before the Louisiana Motor vehicle Commission (the “Commission”) a hearing in the matter of Parish Truck Sales, Inc. versus Direct Trailer, LP. Parish Truck Sales appeared with its attorney, Mr. Vincent J. Booth. Direct Trailer, through its designated representative, attorney Drew Louviere, notified the Commission that they would not appear, and they did not appear at the time of the hearing, even though properly noticed.

Parish Truck Sales presented the testimony of its vice president Brian Bennett, and introduced documents in support of its claims. Based upon the evidence presented the Commission reached the following findings of fact and conclusions of law:

FINDINGS OF FACT

1. Parish Truck Sales purchased three (3) trailers from Direct Trailer for the sum of \$79,769.00.
2. Parish Truck Sales terminated the franchise with Direct Trailer and requested that Direct Trailer buy back the 3 trailers.
3. The trailers were not altered to the prejudice of the manufacturer.
4. Direct Trailer failed to re-purchase the trailers as requested by Parish Truck Sales.

CONCLUSIONS OF LAW

1. Direct Trailer is subject to the authority and jurisdiction of the Commission.
2. Louisiana law requires that Direct Trailer buy back the three trailers, and to pay the various amounts for expended by Parish Truck Sales for advertising and freight.

JUDGMENT

Based upon the evidence adduced at trial of this matter,

IT IS HEREBY ORDERED that there be judgment in favor of Parish Truck Sales, Inc. against Direct Trailer, LP in the amount of \$79,769.00 and in addition thereto, judicial interest thereon from the date of demand, August 3, 2015.

IT IS FURTHER ORDERED that there be judgment against Direct Trailer, LP for all costs of these proceedings.

JUDGMENT WITH FINDINGS OF FACT AND CONCLUSIONS OF LAW

On September 12, 2016, there was held before the Louisiana Motor vehicle Commission (the "Commission") a hearing in the matter of Parish Truck Sales, Inc. ("Parish Truck Sales") versus G Fabricating, LLC DBA Garcia Industries ("Garcia Industries"). Parish Truck Sales appeared with its attorney, Mr. Vincent J. Booth. Garcia Industries, through its designated representative, Mr. Randy Garcia, notified the Commission that the company would not appear, and Garcia Industries did not appear at the time of the hearing, even though properly noticed.

Parish Truck Sales presented the testimony of its vice president Brian Bennett, and introduced documents in support of its claims. Based upon the evidence presented the commission reached the following findings of fact and conclusions of law:

FINDINGS OF FACT

1. Parish Truck Sales purchased one (1) trailer from Garcia Industries for the sum of \$46,800.00.
2. Parish Truck Sales terminated the franchise with Garcia Industries and requested that Garcia Industries buy back the trailer.
3. The trailers were not altered to the prejudice of the manufacturer.
4. Garcia Industries failed to re-purchase the trailer as requested by Parish Truck Sales.

CONCLUSIONS OF LAW

1. Garcia Industries is subject to the authority and jurisdiction of the Commission.
2. Louisiana law requires that Garcia Industries buy back the trailer, and to pay the various amounts for expended by Parish Truck Sales for advertising and freight.

JUDGMENT

Based upon the evidence adduced at trial of this matter,

IT IS HEREBY ORDERED that there be judgment in favor of Parish Truck Sales against Garcia Industries in the amount of \$46,800.00 and in addition thereto, judicial interest thereon from the date of demand, March 16, 2016.

IT IS FURTHER ORDERED that there be judgment against Garcia Industries for all costs of these proceedings.

(1); and Louisiana Administrative Code Title 46. Part V. Subpart 1. Chapter 7. Advertising §703.A.2.a. & 6.; §745.A.; and §749.A.1.e. and 2.a. & b. In attendance representing Wholesale Auto Group, Inc. was Danny Alonzo, Owner. Mr. Alonzo stated to the Commission Members that his attorney, Victor Loras, informed him late Friday afternoon that Mr. Loras is no longer representing Wholesale Auto Group, Inc. Therefore, Mr. Alonzo is requesting a continuance of this hearing to a later date. A court reporter was brought in to record the transcript of the hearing, which will be made a permanent part of the Commission's files. The hearing was continued to November 14, 2016.

The Executive Director advised the Commission Members there were pre-hearings held on August 31, 2015 and March 14, 2016, and several telephone conference calls pursuant to LSA-R.S. 49:961C, regarding Matter #2014-024, LFT Leasing, Inc. Mac Corporation, DBA Auto Rental Etc., 401 East Pinhook Road, Lafayette, Louisiana 70501 (Collectively "LFT"), for alleged violations of LSA-R.S. 32:1251.; LSA-R.S. 32:1254.A.(2) & (4), C.(6) & (8)(a) & (c); LSA-R.S. 32:1258.A.(1), (2), (4), (6), & (8); LSA-R.S. 32:1261.A.(2) (d) & (e), (3)(a) & (c). In attendance on August 31, 2015 conference representing LFT was Terry McFillen, Owner; Daryl Schoust; Anthony Fazzio, Attorney; and Jeff Moss, Attorney; and representing the Commission were: Chairman Raymond J. CONSENT JUDGMENT

After considering the entire record in this matter, and the interest of the parties in amicably resolving it, **LFT Leasing, Inc. DBA High Performance R V & Trailer Sales** and **Terry G. Mac Corporation DBA Auto Rental Etc.**, hereinafter collectively referred as "Respondents", have consented to a judgment in favor of the Louisiana Motor Vehicle Commission (the "Commission") based upon alleged violations by LFT Leasing, Inc. DBA High Performance R V & Trailer Sales and Terry G. Mac Corporation DBA Auto Rental Etc. ("Respondents") of LSA-R.S. 32:1251.; LSA-R.S. 32:1254.A.(2) & (4), C.(6) & (8)(a) & (c); LSA-R.S. 32:1258.A.(1), (2), (4), (6), & (8); LSA-R.S. 32:1261.A.(2)(d) & (e), (3)(a) & (c).

Therefore, based on the parties' mutual consent;

IT IS HEREBY AGREED by and between Respondent and the Commission as follows:

A. That Respondent waives any further procedural rights or remedies afforded under the law with respect to the Commission regarding the matters that are the subject of the numbered case; provided that nothing herein contained shall prevent or preclude Respondent from filing any complaint with the Commission with respect to any manufacturer;

B. That Respondent waives the requirement that the Commission's judgment recites statement of a findings of fact and conclusions of law, and, to the extent that allegations have been made or contemplated by the Commission or its staff, it is acknowledged and agreed that Respondents have not, and are not, admitting or acknowledging any fact or act alleged or any violation of any law that had been alleged, the Respondents agreeing that they have elected not to contest the violations alleged or the potential violations alleged against Respondents, and the Commission agreeing that all pending allegations, investigations and charges, and all matters, regarding violations or alleged violations of the statutes or rules of the Commission by Respondents, their shareholders, officers or employees, whether alleged or not, or whether the subject of any formal notice or not, are hereby resolved without contest;

C. That Respondent waives all rights to seek judicial review or otherwise to challenge or contest the validity of the judgment entered pursuant to this agreement;

D. That the Commission affirmatively and expressly recognizes and acknowledges that none of the conduct or activity alleged in its complaint or Statement of the Case against Respondents, as amended, alleges fraud or intentional falsehood, nor

have the actions of Respondents, their shareholders, Directors, Officers, or employees, been determined by the Commission to constitute any intentionally false or fraudulent claim or transaction, or conduct on the part of Respondents, or their shareholders, Directors, Officers or employees; and further that the resolution of this matter resolves all matters pending or matters under investigation by the Commission or its staff pertaining to the Respondents or their shareholders, officers, agents or employees; and

E. In the event that Respondent should fail to make any portion of the fine provided for herein, Respondent consents that the Commission may petition, ex-parte, the 24 Judicial District Court, Jefferson Parish, Louisiana for the purpose of making this judgment executory, and Respondent waives service and all defenses in making this judgment executory in accordance with its terms. Respondent further consents to the Commission using summary proceedings to make this judgment executory.

IT IS HEREBY FURTHER AGREED the Notice of Hearing may be used in construing the terms of the order. No agreement, understanding, representation or interpretation not contained in the order or the agreement may be used to vary or contradict the terms of the order.

IT IS ORDERED, ADJUDGED, AND DECREED that Respondents, in complete satisfaction of all above-referenced allegations and violations, shall pay a fine to the Commission in the amount of One Hundred Thousand and No/100 (\$100,000.00) Dollars. This sum shall be paid within five (5) business days of the date of approval of this Consent Judgment by the Commission.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the entry of this Consent Judgment does not constitute or represent an adverse finding as to the business integrity of either Respondents or Terry G. McFillen or any other shareholder, Director, Officer or employee of Respondents as contemplated by LSA-R.S. 32:1254C(8)(a).


